News from the Clerk's Office:

News from the City: The Master attended a virtual coffee afternoon meeting with The Lord Mayor, William Russell on 13 July with other Livery Masters. The Lord Mayor invited the Liveries to give feedback on the impact of Covid-19 on their activities, diversity & inclusion in the Liveries; and business recovery initiatives. The Lord Mayor also asked Livery Companies to consider adopting the Diversity Charter promoted by the City Livery Committee.

On 28 July, the Master was also privileged to watch the **Address to the Judiciary**, hosted by The Lord Mayor, Alderman William Russell, with The Rt Hon the Lord Burnett of Maldon, The Lord Chief Justice of England and Wales and The Rt Hon Robert Buckland, QC MP, The Lord Chancellor and Secretary of State for Justice, via Zoom.
