News from the Clerk's Office: reminder – **Liz Wicksteed** joins us as **Clerk** on 12 October, with **Alison Evans** taking on the role of **Assistant Clerk**. We extend a very warm welcome to Liz. Both hope to be in more regular attendance in the Clerk's office at Glaziers' Hall during the Autumn.

News from the Court.

Election Court: The Court met virtually on 28 September (the *St Matthew's Day* Quarter Court, that traditionally elects all officers for the ensuing year). A list of elected officers is annexed to this e-Update (the 'Installation' will take place at the *St Andrew's Day* Quarter Court on 26 November). The Master, Wardens & the Clerk, with the assistance of the CMDS, continue to explore whether some kind of 'face to face' installation and celebration might be possible at least for a limited number of people. We will let you know, as soon as we can, what we can do.

The Glaziers' Annual Accounts: (2019) were formally approved by the Court and the Clerk and Honorary Treasurer will be providing an abbreviated version of these accounts for a future e-Update.

The Court also agreed to adopt the **Diversity Charter**, mentioned in the August e-Update and as recommended by the Lord Mayor and the City Livery Committee; and a copy of it will be placed on the Glaziers' website. The Company continues to welcome eligible new members from all backgrounds and aims to provide an inviting and enjoyable members' organisation for everyone.

New Freemen: on 28 September, the Court admitted to The Company by way of a virtual ceremony: **TOMASZ BILAKIEWICZ, TIMOTHY (TIM) WRIGHT and RACHEL MULLIGAN (artist)**.

All are now entitled to call themselves '*Freemen of The Glaziers' Company*' and may in due course seek the Freedom of the City of London with a view to becoming Liverymen of The Company. Congratulations, and welcome!

The next Glaziers' Webinar takes place on 18 November at 6pm (UK time): about aspects of two giants of the nineteenth century stained glass world, Pugin & Tiffany. the Master is delighted that Hon Freeman **Dr Jasmine Allen** (Ely Stained Glass Museum and author of *Windows for the World: Nineteenth-Century Stained Glass and the International Exhibitions, 1851-1900*), Hon Freeman **Rolf Achilles** (School of Art Institute of Chicago, & Board Member, Driehaus Museum, US) and Curator **Jennifer Thalheimer** (Charles Hosmer Morse Museum, Florida, US) have agreed to take part, with David Stringer-Lamarre moderating. Stevens Competition: #Stevens 2021 is launched. The Brief for this flagship international annual Competition for new, student & emerging architectural glass artists, based on a commission for the design of an illuminated panel for the reception area of Haberdashers' Aske's School for Girls, Elstree is now **available** on the Glaziers' website:

Thank you to all, and especially to Brian Green, Helen Whittaker, the Clerk, C&CC Chairman Clive Osborne and those at Haberdasher Aske's School – who managed to get this Competition off the ground during lockdown.

#Stevens 2022: looking ahead, the Competition in 2022 will also be a celebration of *fifty* years of the Stevens Competition, and supporting those training or setting out to be architectural glass artists and designers for half a century.

A New 'Silver Book': the Clerk's Office is now working hard to produce a new *Silver Book* (including names and updated contact details of all long-standing and *new* members of The Company), by the end of the calendar year. Glaziers' Company Charitable Donations: following on from City Giving Day (22 September), modest donations have now been allocated on behalf of the Company to the **Royal British Legion** and to the **Lord Mayor's Appeal**.

British Society of Master Glass Painters (BSMGP) & the Artists' General Benevolent Institution (AGBI)- Grand Charity Draw: Assistant Jane Campbell reports "The Draw, originally due to be made at the Glaziers' April Livery Dinner, takes place on 30 September at the BSMGP's AGM. £450 was raised for the AGBI from tickets being purchased for the Draw [by BSMGP & Glaziers members]. The winning prize of a visit to Assistant John Reyntiens Studio who had been restoring the clock faces of Big Ben has been a big enticement to colleagues and friends to buy tickets. The BSMGP is very grateful to him for being so generous. It has also been an opportunity to publicise this charity, highlighting that the AGBI, with its links with the BSMGP, is there helping professional artists including stained glass artists, when they strike difficult times. This is why it is such an important charity to support for the BSMGP."

Livery 'No Going Back' Project: this programme was created to get people into employment on release, and, uniquely, includes accommodation for those leaving prison who might not be able to take up their jobs. Despite the challenges of Covid-19 which includes 23 hour lockdown in the prisons, with the support of 13 Livery companies, **Bounce Back** has been navigating the system to ensure that people can be engaged onto the programme and picked up on release to support them into employment. The key to the programme is jobs, and with talented candidates being released
